Application Instructions

NaturalClear should be applied once the pond is completely ice free with a heavy treatment to kick start the process. Toss packets directly into the water when wind is low. Packets will dissolve and bacteria will be evenly distributed in the water. Maintenance applications should be applied every two weeks.

In general we recommend that maintenance is routinely done from May to September OR as long as the pond remains completely ice free. If the pond has a history of being difficult to manage or growing excessive vegetation, higher application rates can be used safely around fish, plants, birds, swimming ponds, and other wildlife when used according to label directions.
